Article I

ORGANIZATION and PURPOSE

1.1 **Name.** This Club is organized as a not-for-profit corporation under the laws of the State of Connecticut under the name:

“THE INDIAN HARBOR YACHT CLUB Incorporated”

1.2 **Purpose.** This Club is organized to encourage and support the sport of yachting, the art of yacht designing and building, and the science of seamanship and navigation, and to provide for the amusement and recreation of its members.

1.3 **Use of Name.** No member shall use or facilitate the use of the Indian Harbor name to support any cause or objective apart from the Club’s purpose as set forth in Section 1.2 without the consent of the Board of Directors. No member shall use or facilitate the use of the Indian Harbor name for personal benefit.

Article II

MEMBERSHIP

2.1 **Membership Classes.** Each candidate elected to be a member shall belong to one of the following classes of membership: Active, Honorary, Flag, Corinthian, Introductory, Clubhouse and Non- Resident.

2.2 Admissions Procedures. The procedures of the Club for application and admission of members of all classes (“admissions procedures”) will be the procedures which the Board of Directors (the “Board”), upon recommendation by the Admissions Committee, approves and adopts; such procedures may be different for different classes of membership and may be changed from time to time as the Board, upon recommendation of the Admissions Committee, may provide. The admissions procedures for each class of membership shall specify requirements which may include proposing, seconding and supporting letters, meetings with members of the Admissions Committee and posting of notice to members of a candidacy. The Admissions Committee shall maintain a correct statement of admissions procedures which shall be published in the RedBook (or online at the Club’s website) and shall be available to members on request. The By-Laws shall govern in the event of any inconsistency with provisions of the admissions procedures.

2.3 Membership Elections. Any communication and the proceedings relating to the application or election of a candidate shall be confidential and shall be restricted to the Admissions Committee and the Board. All candidates shall be elected by the Board (except for transfers) by ballot, and a single negative vote shall prevent election to any class of membership.

2.4 Special Procedures. Admissions procedures for the election of members (“special procedures”) may be conducted by simplified procedures as provided in the admissions procedures for members in the following circumstances: (i) the election of an Honorary Member, (ii) the election of a Flag member, (iii) the election as an Active member of the surviving spouse of a deceased Active member, (iv) the transfer of a member from one class to another, (v) the election as a joint member of the spouse of a member, or (vi) the reinstatement of a member who resigned within five years of the consideration of reinstatement.

2.5 Effective Date. Election of a candidate to any class of membership and the transfer to a different class of membership shall be effective (“effective date”) on the first day of the month following such election or birthday. The Admissions Committee shall cause notice of each election of a member to any class to be posted, as the admissions procedures shall provide, to give notice to all members.

2.6 Joint Membership. Any married couple, each of whom is eligible therefor, may apply for joint membership in the Active, Corinthian, Introductory, Clubhouse or Non- Resident class. In the case of joint memberships:

- (i) each spouse in the Active class shall be entitled to cast only one-half a vote;
- (ii) the age level of membership of each spouse shall be deemed to be the age level of the older spouse;
- (iii) joint members shall be treated as an individual member of the same class for purposes of all fees, dues, assessments and charges;
- (iv) each spouse shall be fully responsible for the payment of all fees, dues, assessments, charges and other amounts payable by either spouse;
- (v) upon the death of one of the spouses, the surviving spouse shall remain an individual member of the same class, except that a surviving spouse who qualifies under Section 2.9 may elect to transfer to Flag membership;
- (vi) upon a legal separation or divorce of the spouses, each spouse shall remain an individual member of the same class; and
- (vii) if either spouse resigns as or otherwise ceases to be a member of the Club, the other spouse shall remain an individual member of the same class.

2.7 Active Membership. Any person who shall be at least 21 years old when elected, shall be eligible for election as an Active member of the Club. Each Active member shall be entitled to use all the facilities of the Club, to represent the Club, and to display the burgee and other emblems of membership of the Club, to enjoy the privileges and benefits available to members from time to time and to vote in all meetings of the members. The privileges of an Active member are referred to herein as "membership privileges."

- (i) **Family Policy.** The spouse and children (under the age of 21) of an Active member shall be entitled to the use of the facilities of the Club without separate membership.
- (ii) **Domestic Partnership Policy.** Any individual unmarried Member (over the age of 21) who cohabits in a domestic partnership with an unmarried non-member (over the age of 21) may apply to the Admissions Committee for approval of the non-member as a "Domestic Partner." The Executive Committee shall have discretion to approve or disapprove the Domestic Partner. Upon approval by the Executive Committee, the Domestic Partner shall have the same access to and usage of the Club as the Member, but shall not hold office, vote, or have any rights to membership. Domestic Partners shall not be entitled to transfer into Club membership except upon marriage to the Member. The Member must notify the Executive Committee promptly upon the termination of the domestic partnership. Children under the age of 21 of a Domestic Partner shall have the same access and usage of the Club as those of a Member's child of the same membership category. The Member shall be fully responsible for all financial transactions and compliance with the Club's By-Laws and House Rules concerning the Domestic Partner and any children thereof. Upon approval of the Executive Committee, the Domestic Partner shall be listed in the RedBook in the same manner as that of the spouse of an Active member and indicated therein with a (dp).
- (iii) **Rule of 100.** Any Active member who is 70 years or older and has been an Active member for more than 20 years, and whose years of active membership and age add to 100 or more, shall be given notice of the right, upon acceptance thereof, to become a "**Senior Active Member**" within the Active class of membership. Senior Active members shall pay dues and capital assessments at the lower rate specified in the business procedures for this category of Active Membership.

2.8 Honorary Membership. Any person who is, or is eligible for election as, an Active member and who is proposed by the Commodore and seconded by the Vice and Rear Commodores for election as an Honorary member, based upon exceptional service to the Club or the yachting community or extraordinary achievements in the yachting world, shall be eligible for election as an Honorary member. Honorary members shall be entitled to all membership privileges (except the right to vote) but shall not be required to pay any initiation fee, annual dues or assessments. Such proposal shall be made directly to the Board, and election may be for a specified period or subject to the continuance of certain conditions as the Board in its resolution may provide.

2.9 Flag Membership. In such circumstances as the Board shall determine to be appropriate, a surviving spouse of an Active or Honorary member shall be eligible for election as a Flag member. A Flag member shall remain a Flag member until the end of the year in which he or she remarries and may apply to become an Active member in accordance with the admissions procedures. Flag members shall be entitled to all membership privileges (except the right to vote) but shall not be required to pay an initiation fee or capital assessment and shall pay annual dues at the lower rate specified in the business procedures.

2.10 Corinthian Membership. Any person who shall be at least 16 and not more than 20 years old when elected shall be eligible for election as a Corinthian member of the Club. Corinthian members shall be entitled to all membership privileges except the right to vote. The application of any candidate shall be sanctioned by a parent or guardian who shall agree to be responsible for all obligations to the Club incurred by such candidate until the age of 21. A Corinthian member shall remain a Corinthian member until the end of the month in which the Corinthian member becomes 21 years old. A Corinthian member becomes, at age 21, an Active Member and no initiation fee is payable.

2.11 Introductory Membership. Introductory Membership at Indian Harbor Yacht Club is a one-time, one-year membership class intended for candidates who are at least 21 years of age and express an interest in pursuing full Active membership after their introductory period. Introductory members are entitled to all membership privileges (except the right to vote) plus the Focus on Sailing program. Introductory membership is intended to permit this class to experience the full range of activities of the Club and to become acquainted with more members and meet qualifications for Active membership.

2.12. Clubhouse Membership. Any person who shall be at least 21 years old when elected shall be eligible for election as a Clubhouse member of the Club. A Clubhouse member (formerly a “winter member”) shall be entitled to all membership privileges (except the right to vote) but only during the winter season (the period between the de-commissioning of the Club and the commissioning of the Club in the following year).

2.13 Non-Resident Membership. Any person who shall be at least 21 years old when elected shall be eligible to become a Non-Resident member in one of two categories: a Non-Resident (Alpha) candidate, to be eligible for election, shall: (i) not use a residence within 50 miles of the Clubhouse for more than 30 days in any year, and (ii) not moor a yacht in the Greenwich area for more than 30 days in any year. A Non-Resident (Bravo) candidate, to be eligible for election, shall: (i) currently be a member of the Club and shall have been a member for more than three years, (ii) not have his or her principal residence within 50 miles of the Clubhouse, and (iii) not use a residence within 50 miles of the Clubhouse for more than 180 days in any year. In the case of Joint Non-Resident membership, both spouses must meet the criteria for Non-Resident membership. A Non-Resident member shall be entitled to all membership privileges (except the right to vote) and the right of his or her children to use the Club. A Non-Resident member shall remain a Non-Resident member until the end of the month during which his or her place of residence or the mooring of his or her yacht changes so that he or she no longer satisfies the conditions of Non-Resident membership. A Non-Resident member may apply for transfer to become an Active member in accordance with the admissions procedures then in effect.

2.14 Junior Yacht Club. The Club sponsors and recognizes the Indian Harbor Junior Yacht Club which has its own charter, flag officers and membership. Members of the Junior Yacht Club shall have no membership privileges in the Club but, subject to the age qualifications, members of the Junior Yacht Club shall be eligible for election as members.

2.15 Suspension or Termination. Any member of the Club may be suspended for a period of up to one year by the Executive Committee and may be suspended for a period of any duration or terminated upon the recommendation of the Executive Committee and the vote of the Board; provided, however, that such member shall be given notice of the intent to consider suspension or termination of his or her membership at least ten days prior to any action by the Executive Committee and shall be given reasonable opportunity to present information and to appear before the Executive Committee at its meeting to consider such

action. Suspensions and terminations shall be for (i) failure to pay any amount owed by the member to the Club, (ii) breach by the member of the rules of the Club or abuse of the procedures of the Club or privileges of members, or (iii) misconduct or acts which are injurious to the facilities of the Club or which are damaging to the reputation or welfare of the Club. Any suspension or termination shall be effective as of the date specified by the Executive Committee or the Board, as the case may be, or if not specified, as of the date of the meeting at which the action is taken.

2.16 Resignation. Any member may withdraw from membership at any time by resignation which shall be effective as of the later of the date specified in the resignation or the date the resignation is received by the Club. No resignation shall relieve the member of the obligation to pay all amounts due and owing to the Club at the effective date of resignation pursuant to bills rendered or amounts due in accordance with the By-Laws and the business procedures then in effect.

2.17 Reinstatement. A member who has resigned may apply for reinstatement within five years of such resignation pursuant to the special procedures for reinstatement then in effect. Thereafter application for membership must be effected by a new application for ordinary election. A member who has been terminated may not be reinstated. A reinstated member shall be liable to pay the amount of any special assessments which would have become payable during the period of resignation had the reinstated member not resigned.

Article III MEMBERSHIP OBLIGATIONS

3.1 Fees and Dues. The initiation fees and the annual dues to be paid by each class of member shall, upon recommendation by the Executive Committee, be set by the Board; provided, however, that no increase in dues or fees will be put into effect except following the favorable vote of a majority of the members entitled to vote and present in person or by proxy at a regular or special meeting.

3.2 Minimum Charges. Any Active, Flag, Introductory or Clubhouse member who shall incur charges less than an amount ("minimum charge") specified in the business procedures during any specified period, shall be charged the difference between his or her actual charges for such usage and the minimum charge. The minimum charge and charge period applicable to each affected class of member shall, upon recommendation by the Finance Committee, be set by the Board.

3.3 Capital Assessments. There may be an annual capital assessment payable for reconstruction of facilities or construction of capital improvements to the facilities of the Club. The annual capital assessment may be levied by the Board in such amounts, for such purposes and upon such classes as, upon recommendation by the Executive Committee, the Board shall determine; provided, however, that no increase in the annual capital assessment will be put into effect except following the favorable vote of a majority of the members entitled to vote and present in person or by proxy at a regular or special meeting.

3.4 Special Assessments. Special assessments may be levied by the Board in such amounts, for such purposes and upon such classes as, upon recommendation of the Executive Committee, the Board shall determine; provided, however, that no special assessment shall be levied unless it shall have been approved (i) by the Board and by the vote of a majority of the members of the Club entitled to vote and present in person or by proxy at a regular or special meeting or (ii) if the special assessment proposed together with any other special assessment in such fiscal year does not exceed \$100 per Active member, by the Board.

3.5 Business Procedures. The business procedures of the Club for billing and payment of initiation fees, annual dues, minimum charges, capital assessments, special assessments, use charges and junior program or other charges billed to members by the Club will, upon recommendation by the Finance Committee, be submitted for approval by the Board (“business procedures”). The Finance Committee shall maintain a correct statement of business procedures, including the current list of dues, assessments, minimum charges and late charges, which shall be published in the RedBook (or online at the Club’s website) and shall be available to members on request. The By-Laws shall govern in the event of any inconsistency with provisions of the business procedures.

3.6 Initiation Fees. The applicable initiation fee in respect of a class or category of membership shall be due upon the effective date of each of (i) the election of a member to the Club, or (ii) the transfer of a member to a different class of membership. Any initiation fee paid in respect of one class of membership shall be a credit against the amount due upon transfer to a different class or upon reinstatement.

3.7 Dues and Other Amounts. Annual dues shall be payable from the effective date of election, transfer or reinstatement at the applicable rate for such class or category of membership for the part of the year remaining. All amounts billed by the Club shall be due when billed and the business procedures may provide for interest or a late payment charge, not in excess of the rates or amounts permitted by applicable law. The business procedures shall provide that the names of members whose accounts remain unpaid after a specified period shall be posted on the bulletin board in the Clubhouse, in a manner permitted by applicable law, unless the Executive Committee determines to grant an exception to such posting, and the credit of posted members shall be suspended until the accounts are paid in full.

3.8 Withdrawal Payments. All amounts, including any capital assessment, which have been billed by the Club shall be payable and the liability of a member for such debt, together with interest or late charges accruing thereon, shall continue until payment in full notwithstanding the resignation or termination of such member. However, a Member who resigns shall be liable to pay annual dues through the June 30 or December 31 next following resignation whether or not such dues have been billed prior thereto. A Member who is terminated shall not be liable to pay any amounts which have not been billed prior to the date of termination.

3.9 Discretionary Reduction. The Board, in its discretion, may reduce or waive the payment by any member of any fees, dues, assessments or other charges for any period. Any such action of the Board shall not constitute a precedent requiring the extension in time or reduction to other members of such reduction or waiver. The Executive Committee, in its discretion, may reduce or waive the payment by any member of any fees, dues, assessments or other charges outstanding, or which have not been billed but would otherwise be billed, during a period not greater than to the end of the year in which such action is taken. The Treasurer, in his or her discretion, may compromise or settle the amount of any fees, dues, assessments or other charges payable by a member which have been billed and are outstanding.

Article IV GUEST PROCEDURES

4.1 Guest Privileges. The privileges of the members to invite guests to use the facilities of the Club and the procedures pertaining to the introduction of guests (“guest procedures”) will, upon recommendation of the Members Committee, be adopted and amended from time

to time by the Board. The Members Committee shall maintain a correct statement of the guest procedures which shall be published in the RedBook (or online on the Club website) within "House Rules" and shall be available to members on request. A member introducing a guest shall be responsible for the conduct and for payment of any unsettled account of such guest. The Executive Committee or the Commodore acting alone, may in their or his or her discretion, extend the privileges of the Club to visiting yachtsmen or to other guests for any period, and such invitation shall not constitute a precedent to require the extension in time or application to other persons.

Article V MEETINGS

5.1 Annual Meeting. There shall be one regular meeting of the membership each year (the "annual meeting"). The annual meeting shall be held in November or December each year pursuant to a notice of meeting mailed to all members at least twenty days prior thereto. All members of the Club and their spouses may attend the annual meeting.

5.2 Special Meetings. A special meeting of the membership may be called by the Commodore or the Board for any purpose and at any time, and a special meeting shall be called by the Secretary pursuant to the request for special meeting in writing signed by Active members entitled to cast not less than 25 votes and which shall specify the purpose of the requested meeting. Notices of special meetings shall specify the purpose thereof and shall be mailed to all members at least ten days prior thereto. Special meetings shall be open to all members of the Club and their spouses. No business shall be transacted at a special meeting except as specified in the notice thereof.

5.3 Voting. Voting at any meeting may be in person or by proxy which shall be signed and dated (the last dated proxy shall supersede any prior proxy) and may be either directed as to the manner of voting or discretionary. Voting may be by show of hands or by ballot as the chair of the meeting shall determine.

5.4 Quorum. The presence of members entitled to cast not less than 25 votes in person or by proxy shall constitute a quorum for the transaction of any business at an annual or special meeting.

Article VI BOARD OF DIRECTORS

6.1 Directors. There shall be such number of directors as the Board shall fix from time to time consisting of officer directors ("officer directors") and elected directors ("elected directors"). The officer directors, those directors of the Club who shall be directors by virtue of their election as officers or chairs of certain of the standing committees, shall be the Commodore, Vice Commodore, Rear Commodore, Fleet Captain, Secretary, Treasurer and Counsel, and the respective chairs of the Admissions Committee, Regatta Committee, Club Facilities Committee, House Committee, Events Committee, Members Committee, Communications Committee, Junior Sailing Committee. There shall be not more than three at-large elected directors who shall be elected by the members.

6.2 Directors Emeriti. Every past Commodore who is not at the time serving as a director shall be a Director Emeritus and shall be invited to attend all meetings of the Board and to participate in all discussions but not to vote.

6.3 Term. Each officer director shall serve as a director during the continuation of his or her term as an officer. Each elected director shall serve during the term to which he or she has

been elected provided that no elected director shall serve for more than three consecutive years, except that after a lapse of one year, such person shall again be eligible for reelection. The Board may elect any eligible person to fill any director vacancy, such successor to serve until the next election of directors at an annual or special meeting of the membership.

6.4 Eligibility. Only members of the Club and their spouses may serve as flag officers, officer directors or elected directors.

6.5 Nominations. Nominations for officer directors and for elected directors shall be made by the Nominating Committee, and the Committee's nominations shall be mailed to the members at least thirty days prior to the annual meeting. Nominations may also be made by open nominations signed in each case by Active members entitled to cast not less than ten votes. The list of all nominees shall be included in the notice of meeting mailed to members at least twenty days prior to the annual meeting except that any open nomination delivered to the Secretary after the notice of meeting has been mailed shall be so delivered to the Secretary at least ten days prior to the annual meeting. The Secretary shall notify the members of any such open nominations promptly after receipt thereof.

6.6 Authority. Subject to the By-Laws and any special action of the members, the Board of Directors shall have entire authority to manage the affairs, finances and property of the Club and to delegate their authority, including delegations contained in the By-Laws, to the committees, officers, employees or agents of the Club, including specifically authorizations, in the name of and on behalf of the Club, for (i) the signing of checks, notes or other obligations or orders for the payment of money, and (ii) entering into or executing and delivering any and all deeds, bonds, mortgages, contracts and other obligations or instruments, such authority being either general or specific and subject to such limitations and restrictions as the Board shall determine. The Board shall appoint all standing committees and may constitute and appoint any special committees, except as restricted by the provisions of Article VIII relating to the composition and nomination of committees. The Board shall cause the financial statements of the Club to be audited, and the Audit Committee shall report to the Board on any material changes or adjustments in the financial statements required as a result of the audit.

6.7 Meetings. The Board shall determine its schedule of regular meetings, and if the Board shall have approved an annual schedule of meetings, no other notice of meeting shall be required. Any business may be considered at a regular meeting of the Board. A special meeting of the Board may be called at any time by the Commodore or the Executive Committee by notice mailed to members of the Board at least ten days prior to the meeting specifying the date and purpose of the meeting. No business shall be transacted at a special meeting except as specified in the notice thereof.

6.8 Quorum. A majority of the whole Board of Directors shall constitute a quorum at any meeting of the Board.

Article VII OFFICERS

7.1 Club Officers. The Club officers shall consist of the Commodore, Vice Commodore, Rear Commodore, Fleet Captain, Secretary, Treasurer and Counsel. The Flag officers of the Club shall be the Commodore, Vice Commodore and Rear Commodore.

7.2 Term. All of the officers shall be elected at the annual meeting of the membership and shall serve until the next annual meeting or until the election of their respective successors;

provided, however, that the Board by two-thirds vote may suspend or terminate any officer from his or her duties with or without cause and shall appoint a successor to fill any vacancy (except that the successor to the Commodore or Vice Commodore shall automatically be the Vice Commodore or Rear Commodore, respectively) until the next election of officers at an annual or special meeting.

7.3 Commodore. The Commodore shall be the president and chief executive officer of the Club, and shall preside at meetings of the Board and of the membership. The Commodore shall command the squadron of the Club.

7.4 Vice Commodore. The Vice Commodore shall be the vice president of the Club, shall act with the authority of the Commodore in the place of or in the absence of the Commodore, and shall succeed to the position of Commodore if it shall become vacant.

7.5 Rear Commodore. The Rear Commodore shall assist the Commodore and the Vice Commodore in the discharge of their duties and shall perform in any capacity and exercise any authority delegated to him or her by either of them or in the event of the respective absence of either or both of them, and shall succeed to the position of Vice Commodore if it shall become vacant and to the position of Commodore if the positions of both the Commodore and Vice Commodore shall become vacant.

7.6 Fleet Captain. The Fleet Captain shall organize the sailing and racing activities of the Club pursuant to direction from the Flag Officers and the Board, shall chair the Sailing Committee and shall be responsible for direction and coordination of the committees and individuals working on the conduct and administration of regattas hosted by the Club and sailing activities sponsored by the Club.

7.7 Secretary. The Secretary shall give notices of meetings of the membership and the Board as provided herein and shall keep the minutes of such meetings, and shall be responsible for the maintenance of the seal of the Club and cause the Club to comply with legal requirements to maintain its good standing under the laws of Connecticut.

7.8 Treasurer. The Treasurer shall have the responsibility for the funds of the Club and for compliance by the members with the business procedures of the Club, and shall direct the maintenance of the accounting records and the financial statements of the Club.

7.9 Counsel. The Counsel shall advise the officers and the Board of Directors on legal matters affecting the Club, and shall instruct outside counsel retained to act for the Club in relation to questions on which specialized legal advice is appropriate or for judicial or administrative appearances.

7.10 Other Officers. In addition to the officer directors elected by the membership, the Board may, if necessary or convenient for the affairs of the Club, appoint the following additional officers: Measurer, Fleet Surgeon and Fleet Chaplain. Such officers shall perform such functions pertaining to their respective offices as shall be directed by the Commodore or the Board. Such additional officers shall serve for one year or until their respective successors are appointed.

Article VIII

STANDING COMMITTEES; OTHER COMMITTEES

8.1 Committees Generally. The standing committees shall be the committees referred to in Sections 8.2 through 8.17, inclusive. The other committees shall be the committees referred to in Section 8.18. All the standing committees (except the Nominating Committee) shall report to the Board, and all other committees shall report to the Board if the Board so specifies.

8.2 Executive Committee. There shall be an Executive Committee consisting of the Flag Officers and such other members of the Board as shall be appointed by the Board. The Executive Committee shall, to the fullest extent permitted by law and except as provided by these By-Laws or by the Board, have the authority to take any action which could be taken by the Board.

8.3 Nominating Committee. There shall be a Nominating Committee consisting of the most recent past Commodore not standing for re-election (or if he or she shall be unable or unwilling to serve, such other past Commodore as may be appointed by the Board), and four other members proposed by the Board for election by the membership at the annual meeting. The Nominating Committee shall select its own chair from its members other than the most recent (or other past) Commodore. The Nominating Committee shall submit for election by the membership at the annual meeting a slate of nominees as officers and elected directors.

8.4 Audit Committee. There shall be an Audit Committee consisting of a chair and two or more other members or spouses of members of the Club appointed by the Board, at least one of whom shall be a director; provided that no elected officer of the Club or member of the Finance Committee shall be a member of the Audit Committee. The Audit Committee shall review and make recommendations to the Board regarding the selection, retention and termination of the independent auditors; review the proposed scope of the audit and audit-related fees; review the annual financial statements and the results of the audit with management and the independent auditors; review all comments and recommendations of the independent auditors; and recommend and oversee policies and programs on legal and tax compliance, internal control and ethical conduct.

8.5 Finance Committee. There shall be a Finance Committee consisting of the Treasurer, who shall be the chair of the Committee, and such other members or spouses of members of the Club appointed by the Board who may or may not be directors. The Finance Committee shall monitor the financial condition of the Club, receive and review reports regarding the finances of the Club, including all financial statements of the Club audited or reviewed by independent public accountants, review all Club operating, capital expenditure and other budgets and develop long range financial plans for the Club in conjunction with other Committees.

8.6 Sailing Committee. There shall be a Sailing Committee which shall coordinate the sailing activities sponsored by the Club and the regattas hosted by the Club. The chair of the Sailing Committee shall be the Fleet Captain. The members of the Sailing Committee shall include the chairs of the Regatta Committee, Junior Sailing Committee and Cruise Committee, and such other individuals as may be appointed by the Board.

8.7 Admissions Committee. There shall be an Admissions Committee which shall develop and administer procedures for the admission of candidates for membership in the Club and for the transfer of members between classes of membership.

8.8 Club Facilities Committee. There shall be a Facilities Committee which shall oversee the maintenance of and improvement to the Club's buildings (including the interiors) and grounds, shall oversee the marine facilities of the Club and its docks, floats, moorings and boats and shall develop plans with respect thereto in coordination with other relevant committees and individuals.

8.9 House Committee. There shall be a House Committee which shall oversee the Clubhouse and restaurant with respect to hospitality and such other matters and policies as are assigned by the Board or the Commodore.

8.10 Events Committee. There shall be an Events Committee which shall organize all social and entertainment functions and activities of the Club in coordination with other committees and individuals working on these matters.

8.11 Members Committee. There shall be a Members Committee which shall develop programs and policies to promote membership satisfaction and retention and to coordinate the delivery of member services with other committees and individuals.

8.12 Communications Committee. There shall be a Communications Committee which shall oversee communications to the membership through print, web, social media and other appropriate outlets in order to enhance the membership experience.

8.13 Junior Sailing Committee. There shall be a Junior Sailing Committee which shall organize and administer the junior sailing program and oversee the Indian Harbor Junior Yacht Club.

8.14 Regatta Committee. There shall be a Regatta Committee which shall organize all regattas sponsored by the Club and supervise all racing activities of the Club.

8.15 Long Range Planning and Strategy Committee. There shall be a Long Range Planning and Strategy Committee which shall develop long range plans for the Club's facilities and programs.

8.16 Compensation Committee. There shall be a Compensation Committee which shall, subject to any limitations which may be determined by the Board, direct, approve and supervise the employment relation and compensation of individuals on the Club's staff, without derogating from Section 9.2. The Compensation Committee shall be chaired by the Commodore, and shall include as members the other Flag Officers, the Treasurer, the Counsel, and such other members of the Club as the Board may appoint.

8.17 Retirement Plans Committee. There shall be a Retirement Plans Committee which shall administer and oversee the investments and administration of all Club employee retirement plans. Members of the Retirement Plans Committee shall be Trustees of the Club Retirement Plan, originally effective November 1, 1975, as amended. The members of the Retirement Plans Committee shall be members or spouses of members of the Club appointed by the Board, one of whom shall be appointed by the Board as chair.

8.18 Other Committees.

- (i) There shall be a Cruise Committee, a Focus on Sailing Committee, a Young Members Committee and such other committees as the Board may establish and appoint from time to time for such purposes and with such composition as it determines may be convenient or necessary.
- (ii) The Executive Committee may also appoint committees (and any committee may appoint a subcommittee).
- (iii) The Executive Committee or any committee may establish rules and procedures as they deem convenient or necessary to discharge the responsibilities or to act on or regulate any aspect of the work allocated to them.

8.19 Appointment. At the first meeting of the Board subsequent to the annual meeting, or as soon thereafter as is practicable, the Board shall, after consultation with the chair of each respective standing committee and with inclusion of specified members provided in the By-Laws, appoint the members of each standing committee, and may, at any time, appoint the members and chairs of the other committees.

8.20 Terms of Office; Vacancies.

- (i) The members of the Executive, Finance, Retirement Plans, and Audit Committees shall serve for a term of one year or until their successors are appointed by action of the Board. The members of the Nominating Committee shall serve for a term of two years. No member of the Nominating Committee shall serve for more than four consecutive years. The Board shall appoint a successor to fill any vacancy in such committees.
- (ii) The Board shall appoint the members of the standing committees. The members of the standing committees, shall, except as specified herein, serve until the next annual meeting or until their successors have been appointed.

Article IX GENERAL MANAGER

9.1 General Duties and Responsibilities; Reporting. The General Manager shall manage and administer all of the operations of the Club pursuant to the policies adopted by the Board of Directors and consistent with the By-Laws and the approved operating and capital budgets. The General Manager shall report to the Commodore.

9.2 Personnel. Subject to the last sentence of Section 9.1, the General Manager shall be responsible for the hiring, supervision and termination of all employees of the Club, in accordance with Club policies and procedures and all applicable laws and regulations. All employees of the Club shall report to the General Manager.

9.3 Financial Matters. The General Manager shall propose an annual operating budget and an annual capital budget, upon consultation with the department heads and the Standing Committees. Subject to the supervision of the Executive Committee, the Treasurer and the Finance Committee, he shall be responsible for the maintenance of accounting records, the preparation of the Club's financial statements and the observance of the Club's policies and procedures with regard to the deposit and expenditure of funds. All expenditures of Club funds require the approval of the General Manager; individual operating expenditures in excess of \$10,000 require the additional approval of the Commodore or the Treasurer, even if consistent with the approved operating budget; and all capital expenditures must be approved in accordance with Club policies and procedures for capital expenditures.

9.4 Committee Relations. The General Manager shall be an *ex-officio* member of all standing committees, with the exception of the Nominating, Compensation, Executive, Audit and Admissions Committees, and shall effectively communicate, consult and coordinate with all committees of the Club.

9.5 Purchasing. All orders for goods and services to be paid by the Club shall be placed by the General Manager, a person authorized by the General Manager or a Club officer.

Article X AMENDMENTS

10.1 Amendment to By-Laws. These By-Laws may be amended by the Board by the vote of two-thirds of the directors present at any meeting called pursuant to notice mailed to the Board at least ten days prior to the meeting stating the purpose and setting forth the text of the proposed amendment (which may be revised prior to adoption so long as the scope and substance remain the same as stated in the notice); provided, however, that any amendment in the By-Laws or any change in membership obligations proposed by the Board which increases fees, dues, capital charges or assessments which are required in order to maintain membership in the Club may become effective only after a favorable vote of the majority of the members entitled to vote and present in person or by proxy at an annual or special meeting called pursuant to specific notice of the amendment; for purposes of this section, specific notice shall mean notice of the meeting stating the purpose and setting forth the text of the proposed amendment (which may be revised prior to adoption so long as the scope and substance remain the same as stated in the notice) which shall be posted on the bulletin board in the Clubhouse and mailed to every member at least ten days prior to such meeting.

Article XI GENERAL PROVISIONS

11.1 Seal. The corporate seal of the Club shall be a circular device, the rim of which shall contain the words: "The Indian Harbor Yacht Club, Incorporated 1901" with the design of the Indian's head in the center and the words: "Organized July 1, 1889."

11.2 Burgee. The Club burgee shall be a triangular flag, the hoist being two-thirds of the length; the design shall be a red diamond on a white field, the diamond extending from the hoist to the point of the flag.

11.3 Night Signal. The night signal shall be a red light over a white light displayed at a proper height.

11.4 Broad Pennants. The Commodore's pennant shall be a rectangular flag with a blue field, having a white diamond in the center extending from the hoist to the edge of the flag and having three blue stars set in the center of the diamond; the width of the diamond shall be one half of the width of the flag, and the hoist shall be two-thirds of the length. The Vice Commodore's pennant shall be the same design as the Commodore's pennant substituting a red field, a white diamond and two red stars. The Rear Commodore's pennant shall be the same as the Commodore's pennant substituting a white field, a red diamond and one white star. The Fleet Captain's pennant shall be the same as the Rear Commodore's pennant substituting a blue fouled anchor for the star.

11.5 Interpretation. All words included herein which are of the masculine gender shall be interpreted to include the feminine gender, in addition or in the alternative as the context may require. Any provision herein requiring the mailing of notice to the members of the Club, or to the Board or a member thereof, shall be interpreted to include either United States mail or electronic mail.

11.6 Fiscal Year. The fiscal year shall be determined by the Board. All references to a “year” in these By-Laws shall, unless otherwise specified, refer to a calendar year.

*Children of Active Members pay an Initiation Fee of 50% of an Active Member in the age groups 21-23, 24-26 and 27-29.

All initiation fees are subject to a 10% Connecticut tax.

- 1.1 The applicable initiation fee in respect of a class or category of membership shall be due upon the effective date of each of (i) the election of a member to the Club, or (ii) the transfer of a member to a different class of membership. A member- elect must either (i) pay the Initiation Fee in its entirety within thirty days from the date of notification or (ii) pay 1/2 of the Initiation Fee within 30 days of election and the balance in equal installments over the following 11 months. The Controller's office must be notified if the latter option is chosen. For deferred amounts, interest will be charged at an annual rate of 4%. Failure to pay the fee in full or any one of these installments within 30 days of notification will void the member's election.
- 1.2 Any initiation fee paid in respect of one class of membership shall be a credit against the amount due upon transfer to a different class. However, no initiation fees shall be payable by a Corinthian member upon transfer to Active membership. No initiation fees shall be payable by an Active or Non-Resident member upon passing to a different age category in the same class of membership.
- 1.3 A reinstated member will be required to pay the difference in initiation fees between the class before the resignation and the class at the reinstatement. If re- elected more than five years after resignation, the re-elected member will be required to pay the full initiation fee.
- 1.4 Initiation fees are non-refundable and not prorated upon termination or resignation of membership.

The annual fee for participating in the Focus on Sailing program is included in the Introductory Membership Dues for the member, spouse and children under the age of 21.

- 21 The full amount of the annual dues, with the exception of Clubhouse and Introductory Members, shall be billed on December 31 and accrue and become a debt to the Club on the first day of January each year. Dues for Introductory members will be billed in the month they are admitted. Dues for Clubhouse members will be billed on October 31 for the period until the next Commissioning. Dues will be billed annually, but a member may request in writing to the Controller's office to be billed semi-annually or quarterly. A new member's dues shall be pro-rated from the first day of the month following the election.
- 22 A member who resigns from the Club shall be liable for the payment of full annual dues for the year of resignation, regardless of billing arrangement, unless the resignation is received at the Club in writing on or before June 30, in which case the member is liable for the first half of the annual dues only. Dues for the

following year will not be charged to a member if the resignation is received at the Club in writing on or before December 31.

- 23 In the event of the death of a member, the estate shall be liable for the dues for the half-year in which the member died. In hardship cases, however, the dues payable by the estate of a deceased member may be waived at the discretion of the Executive Committee.
- 24 A schedule of Junior Sailing fees shall be proposed by the Junior Sailing Committee in consultation with the General Manager and after approval by the Executive Committee shall be posted on the IHYC website no later than March of each year.
- 25 A schedule of Frostbiting fees shall be proposed by the IHYC Winter Sailing Association in consultation with the General Manager and after approval by the Executive Committee shall be posted on the IHYC website no later than November of each year.
- 26 The schedule of fees for Focus on Sailing (FOS) usage and privileges of the club-owned Ideal 18 fleet shall be proposed by the Sailing Committee in consultation with the General Manager and after approval by the Executive Committee shall be posted on the IHYC website no later than March of each year.

- 3.1 Capital Assessments shall be billed on December 31 and become a debt to the Club and are payable on the first day of January each year. However, members shall have the option to pay the amount due in equal quarterly installments on the first day of January, April, July and October. A new member's capital assessment shall be pro-rated from the first day of the month following the election.
- 3.2 Capital Assessments for the year will be waived if the resignation is received at the Club in writing on or before December 31 of the prior calendar year. A Member whose resignation is received at the Club after December 31 shall be liable for the full annual Capital Assessment for the next year commencing January1.

- 4.1 If Active, Flag, Clubhouse, or Introductory Members have charged less than the amount specified above for the consumption of food in Club facilities, they shall be charged the difference between their actual charge for such usage and the amount listed above. Credits to the Minimum Charges are only applied for usage paid by the member and not for usage which is reimbursed to the member or paid to the Club by a third-party.
- 4.2 Active and Introductory Members in the category Age 35 (and over) and Senior Active Members, in each case, who are not married may request a reduction of the Minimum Charge to \$400 semi- annually, in writing to the Controller's office.

5. *Indebtedness:*

On the first day of each month, or as soon thereafter as may be practicable, a bill shall be sent to each member indebted to the Club, showing the amount of their house charges and all other indebtedness as of the last day of the preceding month. The payment shall be made by check or with the agreement of the Club Controller by a debit to a bank account via Automated Clearing House (ACH). Any fees incurred by the Club for returned checks will be passed on to the member's account.

- 5.1 Accounts not paid in full by the first business day of the month following the month in which the bill is transmitted, shall be charged a monthly late fee of 2% on the overdue balance.
- 5.2 Accounts not paid within 45 days of the last day of the month in which the charges were incurred shall cause the Controller to write a letter informing the member of the arrears.
- 5.3 If payment has not been received after 60 days from the last day of the month in which charges were incurred, the Treasurer shall write a letter informing the member that in accordance with the By-Laws the member's credit has been suspended and the member's name will be posted on the bulletin board in the Clubhouse. A member shall continue to be liable for dues and assessments, but not for the minimum charges, during the period of suspension. The suspension will end and the name of the member deleted from the posting list after payment of the total open account with the Club is received or an arrangement for payment is made with the Treasurer.

- 54 If payment has not been received or an arrangement for payment made after 90 days from the day of the month in which charges were incurred, the Commodore shall inform the member in writing that unless payment or arrangements for payment are made by the next Executive Committee meeting, the membership shall be presented to the Board of Directors for suspension of membership or termination according to Section 2.15 of the By-Laws.
- 55 Any member terminated for non-payment of amounts which have been billed by the Club shall remain liable for such debt, together with interest or late charges accruing thereon, until payment in full is made.
- 56 For Introductory members, if payment has not been received after 30 days from the last day of the month in which charges were incurred, the Controller shall write a letter and email informing the member that the member's credit has been suspended and the member's name will be posted on the bulletin board in the Clubhouse in 10 days if full payment is not received. An Introductory member shall continue to be liable for dues during the period of suspension. The suspension will end and the name of the member deleted from the posting list after payment of the total open account with the Club is received or an arrangement for payment is made with the Treasurer.

6. Other Charges:

The Club charges a 10% administrative fee on amounts billed by other clubs for reciprocal services or goods rendered to members. Goods or services which the Club does not provide are excepted. The reciprocal clubs may charge, at their own discretion, a surcharge which is included in their bill.

Except as approved by the Executive Committee, payments by credit card are not accepted from members of reciprocal clubs for any charges or from members with the exception of payments made for the Junior Sailing Program.

7. Discretionary Reduction

Any request for a discretionary reduction of fees, dues, assessments or other charges shall be handled by the Treasurer, the Executive Committee or the Board of Directors in accordance with Section 3.9 of the By-Laws.

8. Guest Charges:

- 81 Members who invite guests to visit the Club in their presence shall accept all charges to be made to their account.
- 82 Unaccompanied guests who identify themselves as members of reciprocal clubs will present the member ID number of their own club. The usage bill including a surcharge of 20% will be sent to their club. A list of reciprocal clubs is available at the Front Desk.
- 83 Any unaccompanied guest, arriving by boat, or sponsored by a member or the General Manager in accordance with the Guest Procedures and who is not a member of a reciprocal club will sign a credit card authorization and is issued a Guest Card which must be presented each time the guest incurs charges at the Club. At the end of the Guest Card period, an administrative fee of 20% will be added to the bill and the guest account is settled by the credit card.

Admissions Procedures

General Provisions

1.1 Applications. Current forms of applications for membership for the respective classes shall be prepared by the Admissions Committee and made available to members upon request. The completed application together with all proposing, seconding and supporting letters (the candidate file) shall be filed with the Club for the attention of the Admissions Committee. The candidate file must be complete before consideration by the Admissions Committee.

1.2 Letters. Each candidate for membership shall be proposed for membership by an Active member and seconded by an Active member. In each instance where membership action is required by an Active member, such action may also be taken by a Non-Resident (Bravo) member. Supporting letters are required as specified herein for the respective classes. There is no required form or content of such letters; however, the Admissions Committee may request a supplement or explanation of any letter. The candidate file, when complete, will be distributed to and reviewed by the Admissions Committee.

1.3 Posting. If the candidate file is in order for consideration by members, the Admissions Committee will direct that, for each new candidate for membership, the names of the candidate and the related proposer and seconder shall be posted by mailing to all members and posting on the membership bulletin board. The posting period is 30 days for all classes of membership; no posting is required for transfers to a different class of membership.

1.4 Election. If the Admissions Committee determines that the candidacy is in order, it shall be submitted to the next following meeting of the Board for consideration pursuant to Section 2.3 (membership elections) or 2.4 (special procedures) of the By-Laws. All candidates for election to any class of membership shall be approved by the Board by ballot in which a single negative vote shall prevent election. The transition of Corinthian to Active member is effected by reaching the designated age, and the transition to Senior Active member is effected by notice to and acceptance by such member of Senior Active status; neither transition requires application or election.

1.5 Transfers. If an Active, Flag or Non-Resident (Bravo) member wishes to transfer to another class of membership, then a request for transfer shall be made by the member in writing to the Admissions Committee. If the request is in order, the request will then be submitted to the Board for election. No other letters are required to propose, second or support the transfer. Clubhouse and Introductory members must apply for Active membership in the same manner as new candidates for Active membership.

1.6 Reinstatement. If a former member who has resigned in good standing wishes to be reinstated, a request should be made in writing to the Admissions Committee. If the request is made within five years of the resignation, it will be presented to the Board for election. If the period between request for reinstatement and resignation is more than five years, the admissions procedure for the class of membership requested shall be followed, with such abbreviation as the Admissions Committee in its discretion shall decide. A former member who resigns and is reinstated and thereafter resigns a second time, shall not, absent extraordinary circumstances, be reinstated a second time.

1.7. Confidentiality. Each candidate file and all proceedings of the Admissions Committee with respect to candidates for membership shall be confidential with disclosure and discussion only among members of that committee and by such members with, and discussions among, members of the Board.

MEMBERSHIP CLASSES

2.1 Active Membership. A candidate for Active membership must be proposed by an Active member and seconded by an unrelated Active member. The candidate must be personally known to both the proposer and seconder. In addition, supporting letters from three other members of any class are required. Each candidate must meet or be known to at least three members of the Admissions Committee.

2.2 Honorary Membership. Any person proposed by the Commodore for election as an Honorary member based upon exceptional service to the Club or the yachting community or extraordinary achievement in the yachting world shall be eligible for election as an Honorary member pursuant to Section 2.8 of the By-Laws. The candidate must be proposed by the Commodore and seconded by the Vice and Rear Commodores. The proposal shall be submitted to the Board, and election may be for a specified period or subject to the continuance of certain conditions as the Board in its resolution may provide. Posting is to inform members of the new Honorary member.

2.3 Flag Membership. The surviving spouse of an Active or Honorary member is eligible for election to this class of membership. The Board may also invite the surviving spouse to apply to become an Active member if the surviving spouse should so prefer. Proposing, seconding and supporting letters are not required. Posting is to inform members of the new Flag member.

2.4 Corinthian Membership. A candidate for Corinthian membership must be proposed by an Active member and seconded by an unrelated Active or Corinthian member. The candidate must be personally known to both the proposer and seconder. In addition, supporting letters from three other members of any class are required. Each candidate for Corinthian membership shall meet or be known to at least three members of the Admissions Committee.

2.5 Introductory Membership. A candidate for Introductory membership must be proposed by an Active Member and seconded by an unrelated Active member. The candidate must be personally known to both the proposer and seconder. In addition, one supporting letter satisfactory to the Admissions Committee is required. Each candidate for Introductory membership shall meet at least the chair and one other member of the Admissions Committee.

2.6 Clubhouse Membership. A candidate for Clubhouse membership must be proposed by an Active Member. The candidate must be personally known to the proposer. Each candidate shall meet or be known to the chair of the Admissions Committee. A Clubhouse member shall be entitled to all membership privileges (except the right to vote) but only during the winter season (between de-commissioning in the fall and commissioning the following spring). Members formerly known as “Winter members” are now Clubhouse members.

2.7 Non-Resident Membership. A candidate for Non-resident (Alpha) membership who meets the qualifications of Section 2.13 of the By-Laws must be proposed by an Active Member and seconded by an unrelated Active member. The candidate must be personally known to both the proposer and seconder. In addition, supporting letters from three other members of any class are required. Each candidate must meet or be known to the chair of the Admissions Committee. Non-resident (Bravo) memberships are processed only by transfer from Active membership status.

PROTOCOL

PROTOCOL

Section I

HOUSE RULES

The Clubhouse

The Clubhouse shall be open on days and during hours established from time to time by the House Committee. Members and their accompanied guests and children are welcome to use all the facilities of the Clubhouse during open hours. Pets are permitted on the grounds only in transit to boats.

Guest Privileges

The privileges of the Club will be extended as a matter of "Club Courtesy" (i) to members of yacht and other clubs which offer reciprocal privileges to our Club, (ii) to visitors arriving on a yacht who are members of American or foreign yacht clubs, (iii) to other members of American or foreign yacht clubs, at the discretion of the General Manager, and (iv) to visitors introduced by a Member to whom a guest card has been issued by the General Manager. Guest privileges may be extended for an aggregate period not to exceed one week for any one guest in a consecutive six-month period.

All children and family of a Member who are age 21 or older are considered guests. There is no limit on how many times children and family of a Member age 21 or older may use the Club in the company of the Member.

Members shall be responsible for their guests adhering to the House Rules. The privileges of guests may be withdrawn at any time by the manager on duty, by the chair of the House Committee, or by a member of the Executive Committee.

Former Members who did not leave the Club in good standing are not permitted to use the Club, even as a guest or when accompanied by a Member.

The General Manager will maintain and annually distribute to all Members a list of reciprocal clubs. Members who wish to visit any of these clubs should contact the General Manager for information on the current procedures.

Procedures

Members of reciprocal clubs will be asked to establish their membership by a member's card or other identification. Guest cards for visitors who are not members of reciprocal clubs or are members of non-reciprocal clubs shall submit a Guest Admission Form available at the Front Desk. The General Manager (or his/ her designee) shall review the form and approve or deny the request. Guest cards for unaccompanied visitors shall be obtained by a sponsoring Member who submits a Guest Admission Form available at the Front Desk. The General Manager (or his/ her designee) shall review the form and approve or deny the request. The sponsoring Member assumes financial responsibility for a sponsored guest, including all charges incurred by the guest. Visitors may be accompanied by their guests. Visiting yachtsmen and yachtswomen may use the Club's guest moorings, launches and docks on

terms and subject to duration limits set by the General Manager. Accompanied guests do not require a guest card and Members shall accept all charges to be made to their account.

Dress

The dress code policy is intended to ensure a pleasant and dignified atmosphere consistent with the yachting tradition of the Club.

Sailing attire is permitted when going to and coming from a boat. Tasteful casual and sailing attire is permitted at the Sunfish Bar, the West Porch and the Bar/Grill Room. Ripped, frayed, tattered or torn clothing and bare feet are not permitted anywhere on Club grounds. Hats, caps, visors and the like (ladies' millinery excepted) must be removed in the Clubhouse.

Smart casual attire is suggested in the Clubhouse and required in the Main Dining Room and South Patio. For men and boys this means a collared shirt (polo acceptable) that is tucked in, turtleneck or sweater and slacks after 1800 hours. There is no jacket or tie requirement. Men must wear closed shoes.

Dress dining attire is required in the East Dining Room and South Porch. For men and boys over age 12, this consists of a blazer or jacket and a collared shirt. While neckties are not required, they are encouraged. Men must wear closed shoes. Dress dining attire for women and girls over age 12 consists of a comparable standard of dress. Denim clothing and cargo pants are not permitted in the dress dining areas.

Children should wear age appropriate clothing consistent with adult dress standards.

Conduct

Proper decorum must be observed at all times in the Clubhouse and on all Club property. Members are responsible for their own conduct as well as the conduct of family Members and guests. If the conduct of any individual is inappropriate, the IHYC staff is authorized to ask the individual to leave.

The General Manager is instructed to bring to the attention of the House Committee and the Flag Officers violations of standards of conduct and dress. Members should bring any problem to the attention of a senior member of the staff.

Reservations

Reservations enable the Club to plan appropriately and serve the membership more efficiently. The Club requests reservations for all Club events and for a la carte dining. Lunch and dinner reservations are recommended. Walk-ins are always welcome and should alert the dining captain to their room preference upon arrival. Visitors to whom Club Courtesy (see guest privileges) is extended may eat in the dress or casual dining areas and are required to make a reservation subject to availability as determined by the General Manager. If a Member or visitor fails to give 24-hour notice of cancellation, a charge may be imposed.

Dining Group Size

Private parties are limited to 12 persons in rooms open for Member dining. Arrangements for larger groups shall be made in advance. The Club is committed to assuring your group

receives the service and attention it deserves while at the same time not impacting the service and dining experience of other Members at the Club.

Evening Colors

At evening colors, a single stroke of the ship's bell will be followed by a cannon signaling sunset and the lowering of the United States flag. Everyone in the Clubhouse or within sight of the flagpole is expected to stand silently at attention until the hail of "Carry On." Members shall assist their guests in respect of this meaningful protocol.

Beverages

Service of alcoholic beverages is governed by the laws of the State which prohibit service to persons under age 21, regulate hours of service, and require consumption on the Club premises. The Board has directed bar and wait staff to decline service to a Member or guest if necessary to preserve the cordial and tranquil enjoyment of the premises or if the person appears intoxicated. Nevertheless, every Member is responsible for his/her guests' consumption of alcoholic beverages and for his or her guests' conduct at all times in keeping with the dignity and decorum expected of all Members.

Smoking

Smoking, including e-cigarettes, is not permitted in the Clubhouse or on the porches, terraces, covered areas such as the Sunfish Bar, or on the floats or launches of the Club.

Business Conduct

While the review of charts, racing rules or sailing material in conjunction with planning or reviewing sailing or racing activity on the Club premises is always appropriate, the conspicuous display of business documents or papers related to personal affairs is not permitted in any of the dining or drinking areas of the Clubhouse. The use of the Library, Sailing Room or the Lounge, if such a room is not then in use by other Members, is acceptable for business or investment consultations.

Communications

Tradition and the necessities of modern life come in conflict as technology creates the possibility for constant communications. Cell phones and other communications devices ("devices") are restricted from use in the Clubhouse or the Sunfish Bar except as follows: devices may receive text messages if set to emit no audible signal; discreet transmission of text messages is permitted; phone calls on devices may be made or received in the Lounge, telephone booths, or second floor rooms (except the Library), if any such room is not then in use by other Members. Such use of devices should be kept to a minimum.

Right to Use Photos, Videos and Sound Recordings

Robust communication is essential to the functioning of a vibrant and successful Club. To enhance the Club's ability to foster such communication, each Member is deemed to grant to the Club the right to make, use and show, without compensation, photographic and video images and other likenesses and sound recordings of such Members and their family members, as well as representations of the Member's yacht(s). Such usage includes, but is

not limited to, the Club's website and social media accounts and Club publications such as *The Log*.

Suggestions

Requests, suggestions and complaints are solicited and will be considered and responded to by the House Committee. Compliments and thanks, which are as welcome as complaints, may be addressed to any member of the staff or to the General Manager or the House Committee.

Respect for Staff

Rudeness or discourtesy to the managers and the staff is unacceptable conduct. The General Manager is instructed to bring to the attention of the House Committee or the Flag Officers conduct by any Member or guest that is rude or disrespectful.

Section II

MARINE PROCEDURES

Floats and Hoists

- All members and paid hands should contact the Marine Staff on VHF Channel 68 for instructions and assistance with lines when docking.
- The furthest south section of the West Docks is solely for the use of Club launches. This launch area can be identified by the black pilings.
- The East Property floats are to be used only for the Junior Sailing Program and for the launching and recovery of dry-sailed dinghies and kayaks. No storage of dinghies other than Junior Program boats is permitted on the east docks.
- Dinghies may be stored either on the dock or in the water north of the cranes. Published storage rates apply. Swamped dinghies may be bailed out by the Marine Staff and the standard labor rate applies.
- All children under 13 years of age must wear PFDs whenever they are on the Club's docks and floats and while in Club launches or other Club boats.
- The large float at the bottom of the ramp directly to the west of the Clubhouse (identified as the "15 Minute Dock") is intended only for loading and unloading of passengers and provisions. In order to facilitate available dock space, there is a 15-minute maximum time limit for this float.
- Any dockside, unattended yacht, boat or tender left without prior arrangements with the Marine Staff is subject to towing. Members will be billed for this service.
- IHYC hoists are to be used only by trained Marine Staff or IHYC members who have undergone training at IHYC and hold a certificate.
- All small dinghies and other drysailed watercraft are to be labeled clearly with the member's last name and display an IHYC ID sticker – available at the Front Desk. Unlabeled boats are subject to removal.

Launch Service

- Launch services are limited to IHYC commissioned and permitted moorings in authorized IHYC mooring areas.
- Launches may be requested in person at the launch desk, hailed by radio via VHF 68, or by sounding three blasts on a foghorn or whistle. Launch services for off-hours may be arranged by reservation. Unscheduled late arrivals may land vessels at our docks but require prompt clearance the following day or other coordination with marine staff.
- The Club launches shall only be operated by members of the Marine Staff.
- In case of emergency or danger, the Marine Staff will do whatever is practicable to ensure the safety of yachts belonging to the members, but neither they nor the

Club assumes any responsibility for such yachts.

- Additional launch and related waterfront requirements are detailed in the annual Waterfront Notice and Mooring and Drysail Agreements.

Section III

YACHT ROUTINE

Flags and Signals

When a yacht is in commission and manned, the following routine and etiquette should be observed:

Ensign

The United States yacht ensign is displayed between morning and evening colors:

(a) When at anchor, at the stern staff. Sailing yachts with overhanging booms locate the stern staff on the starboard side of the boom.

(b) When under way in inland waters and when meeting or passing other vessels on the high seas, weather and rig permitting:

1. By power yachts with gaff, at the gaff.

2. By power yachts without gaff, at the stern staff.

3. By gaff-rigged sailing yachts, at the after peak.

4. By Marconi-rigged sailing yachts, at the leach of the aftermost sail, approximately two thirds the length of the leach above the clew, or at the stern staff.

5. No sailing yacht shall display the ensign while racing.

(c) The ensign shall never be made up and broken out.

Burgee

The burgee is displayed whenever the ensign is hoisted, but may also be displayed separately, between morning and evening colors, at anchor or under way, by:

(a) Mastless yachts or single-masted yachts with bow staff, at the bow staff.

(b) Single-masted yachts without bow staff, at the truck.

(c) Yachts with two or more masts, at the foremost truck.

(d) Yachts can fly the Yacht Club burgee except when the boat is under charter to a non-member.

Private Signal

The private signal may be displayed between morning and evening colors by:

(a) Mastless yachts when under way, at the bow staff in place of the burgee.

(b) Single-masted yachts with bow staff, at anchor or under way, at the truck.

(c) Single-masted yachts without bow staff, when under way, at the truck in place of the burgee.

(d) Yachts with two masts, at the aftermost truck.

(e) Yachts with more than two masts, at the main truck.

Flag Officers' Flag

A Flag Officer and a Fleet Captain shall display their flag day and night at the Club's anchorage and in adjacent waters, at Club-sponsored functions, whenever representing the Club, and at other appropriate times, in place and instead of the private signal, except when racing or displaying the burgee of another club or race committee flag.

Race Committee Flag

On a yacht acting as Race Committee boat, the Race Committee flag shall be displayed, at all times while acting as such, at the main truck in place of the flag otherwise there displayed, at all times while acting as such.

Union Jack

The Union Jack may be displayed at the jackstaff on sailing yachts and on power yachts with more than one mast, between morning and evening colors and only while at anchor on Sundays and holidays or when dressing ship.

Absent Flag

A rectangular blue flag may be displayed at the starboard main spreader between sunrise and sunset, at anchor or under way, when the owner is not on board. An absent signal does not exempt a yacht from observance of prescribed routine.

Guest Flag

A rectangular blue flag with a white diagonal stripe from top of hoist to bottom of fly may be displayed at the starboard main spreader between sunrise and sunset at anchor or under way when guests are aboard during the absence of the owner.

Other Flags

Flags authorized by naval, military or recognized yachting organizations may be displayed at option in accordance with their respective regulations.

Racing

While racing, yachts shall comply with pertinent sections of the Racing Rules, and any specific instructions of race committees, where these conflict with any provision of Yacht Routine.

Size of Flags

The sizes of flags should conform to size of yacht and staff at which they are displayed.

(a) The ensign should approximate a minimum of one inch on the fly per foot of overall length, with a hoist of two-thirds of the fly.

(b) The burgee, private signal and Flag Officer's flag should be approximately one-half inch on the fly for each foot of the highest struck above the water on sailing yachts, and for each foot of overall length on power yachts. The hoist shall be two thirds of the fly.

PROTOCOL

Order of Colors

When making colors shorthanded, the ensign shall be hoisted first, followed as rapidly as possible by the Club burgee and private signal. Flags are lowered in reverse order. Colors are hoisted smartly but lowered ceremoniously. Flag Officers' flags, though normally displayed day and night, may be lowered and hoisted at colors.

LIGHTS

Flag Officers' Lights

When at anchor, flagships may display, from sunset to sunrise, two lights arranged vertically to starboard and abreast of the mainmast at the height of the lower main spreader. Such lights shall be: for the Commodore-blue; Vice Commodore-red; Rear Commodore-white.

Absent Light

When an owner is not on board, a blue light may be displayed at the starboard main spreader when at anchor, from sunset to sunrise.

Searchlights

Searchlights shall be handled carefully, and in such a way as not to blind or confuse those aboard other yachts or vessels.

Anchor and Running Lights

Anchor and running lights shall be displayed in compliance with government regulations.

Colors and Time

Yachts and shore stations shall make colors at 0800 and at sunset. Time shall be taken from the senior officer present.

When in company with a vessel of the United States Navy or Coast Guard, or at a United States Naval or Coast Guard Station, or in the home anchorage of another club, time shall be taken from such vessel, station or club.

In making colors, the yacht always represents the rank of her owner, whether he is on board or not.

Yachts shall take time for striking bells as prescribed in the preceding paragraphs.

On entering or leaving a port before or after the time for making colors, a yacht shall display her flags provided there is sufficient light for them to be recognized. Colors shall be lowered promptly after anchoring or after leaving port.

Half Masting Flags

The ensign is half-masted only on occasions of national mourning. On Memorial Day the ensign is half-masted from 0800 to 1220. On the death of a yacht owner, the burgee and private signal are half-masted on his yacht. When mourning is ordered for the death of a

member, other members' yachts at anchor, the Clubhouse and stations shall half-mast the burgee only.

If not previously hoisted, flags shall be first mast-headed and then lowered to half-mast.

The ensign is mast-headed before making or returning a salute.

PROCEDURE

Official Visit of Flag Officer

When a Flag Officer makes an official visit, his flag, if senior to that of the yacht boarded, shall be displayed in place of the burgee while he is on board.

Unofficial Presence of Flag Officer

A Flag Officer aboard a boat not displaying his distinctive flag should be considered as present in an unofficial capacity.

Distinguished Visitors

A yacht should display the personal flag of a national, state or municipal officer, or the national ensign of the country of a distinguished foreign visitor, when such a person is on board. This flag is displayed in place of the private signal or Flag Officer's flag for the President of the United States, and in place of the burgee for all other officials and visitors.

Dressing Ship

On the Fourth of July, and when ordered on other occasions, a yacht in commission shall, when at anchor and the weather permits, dress ship from morning to evening colors. Rectangular flags should as far as possible alternate with pennants. Ensigns, burgees, private signal and Flag Officers' flags shall not be included among code flags and pennants in the hoist in dressing ship.

Annual Cruise

A yacht which has joined the squadron during the annual cruise shall request permission before leaving. When meeting squadrons of other clubs, salutes shall be exchanged by the senior officers present. When meeting a single yacht, the salute shall be answered only by the flagship.

When Visiting Ports of Other Nations

Between morning and evening colors, when at anchor or under way, the foreign national ensign is displayed by:

- (a) Mastless yachts at the bow staff;
- (b) Single masted yachts at the starboard spreader;
- (c) Yachts with two or more masts at the foremost starboard spreader.

Departure from the foregoing provisions may be to conform to local custom.

Shore Stations

The mast is considered as the mast of a ship standing out to sea.

(a) The United States yacht ensign may be displayed between morning and evening colors:

1. On a mast with gaff and yard, at the gaff.
2. On a mast with gaff, at the gaff.
3. On a mast with yard, at the masthead.
4. On a bare mast, at the masthead.

(b) The burgee is displayed between morning and evening colors:

1. On a mast with gaff and yard, at the masthead.
2. On a mast with gaff, at the masthead.
3. On a mast with yard, at the masthead in place of the United States yacht ensign.
4. On a bare mast, at the masthead in place of the United States yacht ensign. In case of a mast without gaff, the United States yacht ensign may be displayed on a separate mast.

(c) Honors are paid a foreign visitor by displaying his national ensign simultaneously with the United States yacht ensign, between morning and evening colors, in the case of:

1. A mast with gaff and yard, at the starboard yardarm with the United States yacht ensign at the gaff.
2. A mast with gaff, on a separate mast at the level of the United States yacht ensign.
3. A mast with yard, at the port yardarm with the United States yacht ensign at the starboard yardarm and the burgee at the masthead.
4. A bare mast, at the head of one of two separate staffs of equal height, the United States yacht ensign being displayed at the head of the staff on the right facing the sea. The staffs should be located in a manner to avoid placing the burgee at the masthead of the bare mast in the position of honor.

(d) The flag of the senior Flag Officer present may be displayed at the starboard yardarm, between morning and evening colors.

Section IV

DRESS REGULATIONS

Buttons

The Club buttons shall be of two kinds, gilt and black, and of three sizes in black and two sizes in gilt. Large, 34 ligne, for service dress; medium, 24 ligne, for waistcoat and for sleeve buttons on the mess jacket; small, 22 ligne, in black, only for cap; bearing as a device the Club seal. New buttons, both black and gilt, which are flat and have the "Indian Head" and the letters "I.H.Y.C." thereon, are optional with the above and are of the following sizes: 36 ligne for day coat, 32 ligne for evening coat and 24 ligne for sleeves.

Cap

Of navy blue cloth or white duck, with black lustrous mohair braid band one and five eighths inches wide; crown for size seven and one-eighth cap to be nine and seven-eighths inches long by nine and one-quarter inches wide; quarters of cap to the crown seam in front, one and three-eighths inches, same at sides and back; visor of black patent leather, two inches wide and set at an angle of forty-two degrees; chin strap of black patent leather fastened at side with two small black buttons.

Cap Device

For Commodore. Two crossed fowl anchors, one and three-eighths inches in length, with flukes down, embroidered in gold, at their intersection a raised disc five eighths of an inch in diameter, showing the Club burgee on black background, the whole embroidered with colored silk or enameled on metal, the disc surrounded by narrow gold bullion, and a gold star on half of an inch in diameter at each end of, and one above, the device, with a space of three sixteenths of an inch between the device and stars, to be worn on the band.

For Vice Commodore. Same as for Commodore, omitting the star above device.

For Rear Commodore. Same as for Commodore, omitting two stars at ends of device.

For Past Commodore. Same as for Commodore, replacing the three gold stars with three silver stars.

For Captains and Ex-Flag Officers. Same as for Commodore, omitting stars.

For Fleet Captain. Same as for Captain with fowl anchor in gold one half of an inch long, placed above device, and placed horizontal.

PROTOCOL

For Secretary. Same as for Fleet Captain, substituting a maple leaf in gold.

For Treasurer. Same as for Fleet Captain, substituting an acorn in gold.

For Fleet Surgeon. Same as for Fleet Captain, substituting a right-angle red cross with arms of equal length placed on arm vertical.

For Fleet Chaplain. Same as for Fleet Captain, substituting a gold cross one half inch high with three eighths inch cross arm.

For Measurer. Same as for Fleet Captain, substituting a gold bar.

For Regatta Committee. Same as for Fleet Captain, substituting a foul anchor in gold, one-half inch long, placed above device, and placed vertical.

For Members. Same as for Captain, omitting one anchor, the remaining anchor to be vertical.

Mess Jacket

The mess jacket, of blue worsted or gabardine, cut like prevailing style of dinner jacket; single-breasted rounded fronts; no vent; long rolled peak lapels to button one button; collar of same material; lapels faced with surah silk, button hole in left lapel; side pocket with welt; out and inside breast pocket; edges single-stitched by hand, no braid; designation of rank on sleeves as prescribed for service dress, except to be of black flat silk braid one quarter of an inch, with four medium size gilt buttons; the first button to be placed seven eighths of an inch from lower end cuff, the others three-quarters of an inch apart; closed cuffs; device on collar embroidered in gold bullion, same as prescribed for cap device for members, but reduced to three quarters of an inch in length.

Waistcoat blue or white with four small gilt buttons. Black tie or official Club tie to be worn.

Service Dress

Double-breasted sack coat of blue or white cloth, serge or flannel; blue or white waistcoat, each with the Club button. Black buttons on the blue, and gilt buttons on the white. Trousers of the same material as coat, or of white or gray flannel.

Black tie or official Club tie to be worn.

Cloak

The cloak is to be cut three fourths of a circle, of a length to reach the knee, to be made of dark navy blue vicuna cloth (smooth faced).

Designation of Rank

The designation of rank shall be worn on the sleeve on all coats as follows:

Mess jacket material and spacing as designated above.

Black on blue clothes; white on white clothes.

By the Commodore. Five stripes of heavy mohair tubular braid, three-eighths of an inch wide the first placed two inches from end of cuff; the other above, and one quarter of an inch apart, the upper stripe ending in a described trefoil on the upper side of the sleeve, three gilt stars, placed one in the center of each loop of the trefoil on each sleeve.

By the Vice Commodore. Four stripes as above. Two gilt stars placed one in the center of each of the lower loops of the trefoil.

By the Rear Commodore. Three stripes as above. One gilt star placed in the center of the upper loop of the trefoil.

By Past Commodores. Five stripes as Commodore, replacing the gold stars with three silver stars.

By the Secretary, Treasurer, Measurer, Fleet Captain, Fleet Chaplain, Fleet Surgeon, and Regatta Committee. Two stripes and trefoil with the insignia of the respective officers, similar to those listed for the cap device, placed in the center of the upper loop of the trefoil.

By Captains. Two stripes as above, with the trefoil.

By Members. One stripe as above, with the trefoil.
